

#### Mechanism/ Norms and Procedure for Democratic/ Good Governance

Utilizing an ERP system for collecting feedback can streamline the process, making it more efficient and organized. This approach also allows for easy analysis and tracking of feedback data over time, which can help identify trends and areas for improvement.

#### Grievance Redressal Mechanism for Faculty, Staff and Students

Allenhouse Institute of Management has established a Grievance Redressal Committee, led by the Director, to address concerns from students and staff. Complaints can be submitted orally, via email, through ERP, or in writing. Oral complaints will be documented by the receiving GRC member and authenticated by the complainant.

Upon receiving a complaint, the Committee Chairperson will promptly acknowledge its receipt. Depending on the nature and severity of the issue, the Chairperson may pursue one of two options:

Option 1: For routine matters, the Chairperson may directly engage with the relevant department. The complainant will be kept informed of progress or actions taken.

Option 2: For serious concerns, the Chairperson, in consultation with the GRC, may convene a meeting. Depositions may be sought from both the complainant and the department in question. The GRC will communicate its decision to the complainant within 15 days of receiving the complaint.

Decisions will be communicated to relevant parties/departments via email.
