

Memorandum of Understanding

Between

Allenhouse Institute of Management (Having its Address at Plot no.176 B, Kulgao Road, Rooma, U.P 208008)

And

Arth NGO (117/L-18, NaveenNagar, Kakadeo, Kanpur - 208025)

Preamble

This Memorandum of Understanding (MoU) is made and entered into on this ____ day of _____, 2024, by and between Allenhouse Institute of Management (hereinafter referred to as "AIM") and Arth NGO (hereinafter referred to as "NGO"), collectively referred to as the "Parties."

1. Purpose

The purpose of this MoU is to establish a framework for collaboration and cooperation between AIM and NGO in areas of mutual interest, specifically focusing on environmental education, sustainability projects, and community development initiatives.

2. Areas of Collaboration

The Parties agree to collaborate in the following areas:

2.1 Educational Programs and Workshops

- Development and delivery of educational programs and workshops on environmental sustainability and business practices.
- Joint seminars, lectures, and conferences involving students, faculty, and community members.

2.2 Research and Development

- Joint research projects on sustainability and environmental impact.
- Development of case studies and research papers for publication.

2.3 Community Outreach and Development

- Implementation of community projects aimed at promoting sustainable practices.
- Engagement with local communities to raise awareness and foster participation in environmental conservation.

2.4 Internships and Volunteer Opportunities

- Providing students from AIM with internship opportunities at NGO.
- Facilitating volunteer opportunities for students and faculty in NGO's projects and initiatives.

2.5 Skill Development

- Creating and delivering training programs aimed at enhancing skills related to environmental conservation, sustainable business practices, and community development.
- Organizing skill development workshops and courses for students, faculty, and community members to improve their practical knowledge and employability in the field of sustainability.

3. Roles and Responsibilities

3.1 Allenhouse Institute of Management

- Provide academic resources, faculty expertise, and student participation.
- Organize and host educational programs, seminars, and workshops.
- Support joint research initiatives with access to research facilities and funding (if applicable).

3.2 Arth NGO

- Share expertise in environmental sustainability and community development.
- Facilitate access to fieldwork opportunities and community projects.
- Provide guidance and supervision for interns and volunteers.

4. Funding and Resource Allocation

The Parties agree to explore funding opportunities and allocate resources necessary for the successful implementation of joint activities. Specific financial arrangements will be discussed and agreed upon in separate agreements as needed.

5. Duration and Termination

This MoU will remain in effect for a period of three (3) years from the date of signing, unless terminated earlier by either Party with a 30-day written notice. The MoU may be extended or modified by mutual written consent of the Parties.

6. Confidentiality

The Parties agree to maintain the confidentiality of any sensitive information shared during the course of collaboration and to use such information solely for the purposes outlined in this MoU.

7. Dispute Resolution

Any disputes arising from or in connection with this MoU shall be resolved amicably through mutual discussions. If unresolved, the dispute shall be referred to mediation or arbitration as agreed upon by the Parties.

8. Miscellaneous

8.1 Amendments

- Any amendments to this MoU must be made in writing and signed by both Parties.

8.2 Governing Law

- This MoU shall be governed by and construed in accordance with the laws of [U.P].
